

BHS Passport Change of Ownership Form

**The BHS is only able to make changes to passports originally issued by the Society.
We cannot process any passport issued by another organisation.**

The cost of transferring ownership is £15 (or £10 for registered equine charities). Please enclose your BHS passport with the completed form, along with any proof of purchase you have (a copy is acceptable). If you are unable to obtain the **current registered** owner's signature, you will also need to complete a disclaimer form. **We are unable to transfer ownership to children under the age of 16;** ownership must be in the parent or guardian's name. If the horse is jointly owned, we require all owners' signatures to be on this form.
