WHAT TO WEAR ON YOUR ASSESSMENT DAY

All assessments

For all assessments, it is essential that you bring your riding hat which must meet current safety standards. Please refer to our 'hat guidance' on our website for the current accepted standards. Gloves are required for all assessments. Neat and tidy clothing will make a good impression for your assessment, as it would in any professional equestrian workplace. For safety reasons, any jewellery on show should be covered up or removed and long hair tied back. Keep an eye on the weather and ensure you bring suitable clothing if it is likely to be cold or raining - this will ensure you can concentrate on your assessment as opposed to feeling cold or uncomfortable.

If you are riding or teaching, your riding boots can either be long boots or short boots with leather gaiters. Plain jodhpurs or breeches are ideal. Show jackets are not essential, but a smart appearance is recommended.

When riding, we ask that for safety reasons you avoid wearing hooded tops and jackets, and your arms are covered to give some protection.

You will want to feel as comfortable as possible in an assessment therefore if you normally wear a body protector please feel free to wear this during your assessment. We strongly recommend that a body protector which meets the current safety standard is worn for all assessments that involve show jumping. You can wear this over or under a jacket or with a plain sweatshirt instead of a jacket. Current body protector guidance can be found on our website.

For flatwork from Stage 2 and above you can ride with a schooling whip up to 39".

For show jumping and cross country it is recommended one whip is permitted for show jumping and must be between 45-75cm and must not be weighted or with a hard point at the end. The end of the whip must be padded. The 'pad' must be smooth with no protrusion or raised surface (which included embroidery) and be made of a shock absorbing material throughout its circumference. Please bring these with you to your assessment.

Any additional items to bring to your assessment are mentioned on the opposite page.

Stage 1, 2 and 3 Care (including lungeing)

It's important that you're comfortable throughout the day. Please wear suitable footwear for handling horses and sensible yard clothing; this may include trousers or jodhpurs (a dark colour is more practical). We recommend that you wear a jumper or gilet with a polo shirt underneath; you will need to be able to move comfortably to complete practical tasks.

Stage 3 Ride (Jump)

For the cross country section you must wear a body protector approved to the current safety standards, and a long sleeved top. You may also wear an air jacket, this is worn at the centre's discretion, please check with the assessment centre. Please note, fixed peaks are not permitted for any cross country jumping.

Stage 2 and 3 Riding Out

Long boots or gaiters and show jackets are not required for this assessment. You may be riding for up to two hours so comfortable clothing is essential. Prepare for the weather and bring waterproof clothing and a change of clothes if necessary. Equipment required for map reading, such as compasses, will be provided for you at the assessment.

READY FOR ASSESSMENT AND COACH ENDORSEMENT

Before you book any assessment with us, we recommend that you undertake regular training from an Accredited Professional. If you require any assistance finding a suitable trainer or centre, please visit our website or give our Education Team a call.

Your BHS Accredited Professional will be able to help you complete the **Ready for Assessment** and **Coach Endorsements** within your skills record.

The skills record should be signed on an ongoing basis as you undertake regular training. We would recommend this should be completed at least one month before your assessment date.

Each stage has a sign-off section that will need to be completed and signed before you take your assessment, stating that you are **Ready for Assessment**.

In addition, some qualifications will also need a **Coach Endorsement**; this may be completed by your coach or someone different, but must be an Accredited Professional in the industry who can assess you against specific criteria of the qualification which can't be assessed on the assessment day. These tasks must be signed-off under supervision **in advance** of the assessment day.

You must bring your completed skills record to your assessment with you to show your assessor.

The nominated Accredited Professional who can complete a **Ready for Assessment** or **Coach Endorsement** may vary according to the level of assessment.

Who can sign-off my skills record?

Any BHS Accredited Professional with the relevant qualification at least one level higher than they are signing off. For example, the Stage 2 Care can be signed off by any BHS Accredited Professional that holds the Stage 3 Care qualification.

Please remember that your skills record is identifying that you are ready for an assessment. This does not mean that you will necessarily be successful in passing the assessment on the day.



STAGE 1 CARE

Care is where your career begins. It provides the foundations of your profession – putting the horse first in everything you do.



You will be able to:

- Carry out routine tasks which will include mucking out, bedding down and providing food and water
- Handle horses in the stable and outside; hold a horse for inspection, lead in-hand, groom and put on rugs
- Tack up and un-tack; including saddle, bridle, brushing boots, and clean tack
- Turn out and catch a horse and handle a horse safely in a field as well as being able to identify regular field checks

- Describe how to care for a horse after riding and the different types of rug they might need
- Understand horse behaviour and health and be able to recognise problems.

Before you book an assessment for your Stage 1 Care, we recommend that you undertake regular training from an Accredited Professional.


Your assessor will come and meet you to run through the process of the day and answer any queries you may have about the assessment. It's likely you will be put into a group of up to three candidates, working with one assessor, and your first task is likely to be mucking out. You will then move on to cover each element of the syllabus.

How long will the assessment take?

The Stage 1 Care assessment will last approximately two hours.

STAGE 1 RIDE

Riding is a partnership built on trust and respect. Stage 1 Ride recognises it as a profession. Your progressive riding qualifications start here.



You will be able to:

- Mount from a block and adjust the girth and stirrups for comfort
- Walk, trot and canter on both reins, showing changes of direction, turns and circles
- Understand the correct riding position both with and without stirrups and when working over poles
- Ride in a group and show some individual work showing awareness and respect for other riders
- Recognise diagonals in rising trot and identify canter leads as well as applying aids to move around the arena and between paces
- Ride without stirrups in walk and trot and ride a variety of school figures.

- Your Skills Record identification box (page 3) completed or photo ID.
- Your riding hat, gloves and a short whip.

What should I expect on the day?

There will be signs to direct you to the briefing room and a member of our team will be at the centre to welcome you. Your assessor will come and meet you to run through the process of the day and answer any queries you may have about the assessment. For the riding assessment you will be in a group of up to six candidates.

When you arrive at the riding arena (this may be an outdoor or indoor arena) your assessor will allocate a horse to you. When you have your horse, check the tack and prepare to mount, you will then mount the horse from a mounting block and adjust your girth and stirrups as required. Approximately half way through your assessment you will all be asked to halt and dismount and will then ride a second horse.

How long will the assessment take?

The assessment will last approximately 90 minutes.

Co-requisites for the Stage 1 Ride

The silver Riding Out Safely challenge award, (Ride Safe), is a co-requisite for the Stage 1 Ride and must be completed to be awarded the Stage 1 Ride qualification.





STAGE 2 CARE

Whether working with riding school horses or thoroughbreds at stud, this qualification proves you have the essential skills to work as an assistant groom at any yard.

You will be able to:

- Understand the routine practices of a stable yard, your role, responsibilities and reporting lines
- Care for horses on a day-to-day basis
- Recognise normal and abnormal horse behaviour; what may be the cause and what may be done
- Check the fit of tack for comfort; including saddle, bridle, martingale and boots
- · Plait, trim and bath horses
- Fit travel equipment and load a horse onto a trailer or lorry
- Apply stable bandages

- Recognise potential hazards in the working environment which could include; stables, fields and transportation
- Feed horses and understand fitness, including the factors that will affect the amount of feed a horse will need
- Practise first aid and recognise health problems, how they would be cared for and when to call the vet
- Care for horse's feet: recognise a well shod foot, be aware of noticeable signs of lameness and common wounds
- Understand basic anatomy, location of key organs and the function of the digestive and circulatory systems.

STAGE 2 LUNGE

Demonstrate your skills in lungeing the horse for exercise.



You will be able to:

- Understand the reasons for lungeing horses and how lungeing contributes to their daily exercise
- Competently handle lunge tack, put on and adjust (tack will include bridle, cavesson, saddle, roller, side reins and brushing boots)
- Lunge a horse for exercise with awareness of safety implications
- Work the horse in its basic paces showing consideration for the size of the circle
- Adjust the side reins, handle the lunge line, carry a lunge whip and use suitable aids to work the horse.

- Show greater awareness for individual work and ride on your own in an arena showing walk, trot and canter
- Ride confidently showing changes of direction and pace through school movements
- Show awareness for others when riding in a group or in open order
- Ride outside in an open space

- Jump single fences and a small course of 75 centimetres
- Evaluate your own riding and the way the horse goes both on the flat and over fences

What will I need to bring to the Stage 2 Ride assessment?

- Your Skills Record identification box (page 3) completed or photo ID.
- Your riding hat, gloves, a short whip and a long whip.
- This skills record with completed Stage 2 Ride Coach Endorsement and Ready for Assessment tables.

What should I expect on the day?

There will be signs to direct you to the briefing room, and a member of our team will be at the centre to welcome you. It's best to arrive at least 30 minutes before your briefing as you will need to allow time to walk the show jumping course.

Your assessor will run through the process of the day and will be able to answer any queries you may have about the assessment. For the riding assessment you will be in a group of up to six candidates. When you arrive at the riding arena (this may be an outdoor or indoor arena) your assessor will allocate a horse to you. When vou have your horse, check the tack and prepare to mount, you will then mount the horse from a mounting block and adjust your girth and stirrups as required. You will complete the flat section of your riding assessment first. Approximately half way through your flat riding assessment vou will all be asked to halt and dismount and will then ride a second horse.

After your flat riding session your assessor will have a short discussion with you about the two horses you rode. Due to the nature of riding and the risks involved your assessor will make a decision as to whether it is safe for you to continue to the jumping section. If there is any doubt with regard to your own safety or the horse's safety you will be asked to retire from the riding assessment. If your assessor is happy for you to continue, you will then be allocated a jump horse.

You will warm up your first horse for jumping. Your assessor will confirm which jump to warm up over and will usually specify that you start by jumping a cross pole from trot with a placing pole. This will be followed by jumping a cross pole from canter progressing to an upright and eventually a spread fence. Following this you will then jump a course of fences. You will dismount and ride a second horse over the same course of show jumps.

How long will the assessment take?

The assessment will last approximately two hours.

STAGE 2 RIDING OUT



Whether you are taking short hacks out within a riding centre or longer rides as part of a trekking centre, you will have a responsibility to ensure your riders and horses are safe and well looked after. Begin your career in leading hacks, treks and trails and showcase your combination of riding and customer service skills.

You will be able to:

- Understand the role of a ride leader and your responsibilities when caring for horses and riders
- Ride outside in an open space with confidence, over varying terrain and hazards
- Read a map and understand how to use a GPS system to help locate and navigate through routes
- Assess riders before a hack to ensure they are competent for the level of ride ahead

- Provide basic instruction to novice riders to maintain their safety and control of their horse
- Lead a ride out of up to two hours demonstrating appropriate communication skills and behaviour management techniques ensuring a first class level of customer service
- Follow a designated route and identify and negotiate potential hazards, maintaining the safety for all riders and horses
- Ride and lead another horse and rider.

What should I expect on the day?

There will be signs to direct you to the briefing room, and a member of our team will be at the centre to welcome you. Your assessor will come and meet you to run through the process of the day and answer any queries you may have about the assessment. You will be put into groups of three candidates to one assessor, and you will then begin to work through each element of the syllabus.

You will assess a group of riders (in an arena) for their suitability to take them out for a ride. For the riding assessment you will be in a group of up to six candidates. Your assessor will allocate a horse to you. You will ride as a group and demonstrate light seat and bridging of the reins as well as riding and leading another horse and rider in the arena.

You will also take part in a hack of approximately one hour where you will be asked to be in charge of the ride for some time.

How long will the assessment take?

The assessment will last approximately four hours.

Co-requisites to the Stage 2 Riding Out

The following must be completed before the Stage 2 Riding Out can be awarded:

• Stage 2 Care

Recommendations

The BHS strongly recommends that learners looking to be employed in the industry also hold:

- BHS Equine Specific First Aid or First Aid at Work (three or four day course) or international equivalent
- BEF Safeguarding and Protecting Children workshop or international equivalent.

STAGE 2 COACHING

You never forget a good teacher. They're enthusiastic, encouraging and use their knowledge and passion to transform lives. As can you. Stage 2 Coaching provides you with an opportunity to instil confidence, impart knowledge and inspire others on their equine journey.

You will be able to:

- Understand the role of a coach working with riders of varying ages who are riding as part of their leisure time
- Work with novice riders both on the lunge and lead rein showing an understanding of how basic early skills are established
- Deliver a group lesson which includes flat work and jumping
- Demonstrate an understanding of working with small groups of riders in walk, trot and canter, working on their balance and riding position which may include work with and without stirrups

- Progress flat work to jumping as an integrated session working over ground poles, a single fence, double or related distance. The work should show progression
- Deliver a practical stable management session covering a routine activity
- Understand coaching principles, how riders progress and how to introduce new topics such as jumping and how to deal with problems such as a sudden loss of confidence.

- Demonstrate an understanding of the horse's performance, evaluate its way of going and determine an approach to maintain this
- Deliver aids to benefit the horse whilst taking account of forward movement, rhythm, bend and a working outline
- Understand how to ride lateral work (which includes leg yielding and turn about the forehand) in addition to being able to lengthen and shorten the stride in all paces.


