## **Overstamp form**



By law, all horses with valid 'third country' or non-UK EU passports (including Ireland) must be registered on Defra's UK Central Equine Database (CED). This should be done by a UK based passport issuing organisation within 30 days of the horse arriving in the UK. The UK based PIO then administers the passport, and can complete all future updates to the passport record.

BHS will not overstamp passports that have not been registered in the name of the owner applying for the overstamp; this must be done by the original issuing body of the passport beforehand.

BHS is unauthorised to manage studbooks (passports containing DNA testing) - for advice regarding overstamping a studbook passport, please contact BHS passport office.

## To apply for a BHS overstamp:

- 1) Overstamp form must be completed and signed by the current registered owner of the animal (the overstamp cannot be completed if the passport is not registered to the owner applying for the overstamp)
- 2) Select payment and processing method on form overstamp service **costs £22.50** for horse owners (£17.50 for registered equine charities)
- 3) Submit the equine passport to the below address with the completed form **BHS cannot overstamp passports containing DNA testing (name of sire/dam/other genetic relatives)**

The application will be processed within 10 days of arriving with BHS Passport Office, subject to correct paperwork
